We are pleased to announce that Preferred Meal Systems, Inc. will be our food provider for all student meals this year. Our school participates in the Community Eligibility Program, and all enrolled students of Greater Heights Academy are eligible to receive breakfast and lunch at school at **no charge** to parents each day of this school year.

You may view the daily breakfast and lunch menus at the Preferred Meal Systems website, which is www.preferredmealsmenu.com. Click on "Find Your School" on the left side, select "MI" and "Greater Heights Academy", and display menus. In addition, nutrition information for meals can also be viewed by scrolling over the food item on each menu. Meals supplied by Preferred do **not** contain pork products; all meat served is either turkey or beef.
