- **8. Principal Report** Mr. Johnson for Principal DeNesha Rawls-Smith
 - a. Delivery of Instruction
 - Continue 100% remote learning
 - Remote in remote learning status based on MDHS and given some staff have come in contact with individuals that tested positive over the Thanksgiving holiday.
 - b. Two-way Interaction Rates
 - 69% to 83% for October attendance participation
 - 53% to 73% for November attendance participation (decline week of Thanksgiving holiday)
 - 65% for December attendance participation
 - Teachers allowed students to continue to submit work during the holiday to make up work that might have been missed.
 - Respective goal of management to get attendance above 90%
 - All stakeholders are in agreement to make sure students are in attendance, participating in sessions, and completing work
 - Leadership sent out attendance letters to students/parents that have been consistently/persistently absent (19 letters to parents for students that had 10-12 absences)
 - o Additional letters sent for reporting to court systems for students/parent with more than 15 absences
 - Follow-up communication and intrinsic motivation initiatives to get students participate; packet distribution has been reinstituted.
 - O Devices are broken/damaged at a high rate (vandalism, theft) limited number of devices for redistribution.
