

SCHOOL-PARENT COMPACT

School Responsibilities

Kids Care Elementary will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

Every student will receive an Individualized Learning Plan that will indicate quarterly academic goals. The Individualized Learning Plan will be reviewed with the parent during parent-teacher conferences and referenced in all future parent meetings.

The students will participate in a school wide intervention block. This time is designed to provide remediation in skill areas of deficiency.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.

The dates for parent / teacher conferences for the 2020-2021 school year will be communicated during the first week of the new school year. Conferences for the remainder of the 2020-2021 school year will be held by appointment, when needed or requested by the parent.

3. Provide parents with frequent reports on their children's progress.

Specifically, the school will provide reports as follows:

Academic reports are sent home at the end of every quarter in the form of a report card. In addition, the teachers will send home graded assessments and classwork as a means to track academic progress.

4. Provide parents reasonable access to staff.

Specifically, staff will be available for consultation with parents as follows: Parents are able to access staff members via email and phone. Staff members are also available on an appointment basis.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Parents may observe classroom activities by making a request to office personnel. Teachers will communicate individual classroom volunteer needs via newsletter directly to the parents of the students they serve. Parents may inquire in the office for school level opportunities.

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- Ensuring students attend school consistently and on time.
- Making sure that homework is completed.
- Monitoring amount of television their children watch.
- Volunteering in my child's classroom.
- Participating, as appropriate, in decisions relating to my children's education.
- Promoting positive use of my child's extracurricular time.
- Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.
- Encouraging my child to follow the school's behavior expectations
- Attend meetings when requested by my child's teacher

OPTIONAL ADDITIONAL PROVISIONS

Student Responsibilities (revise as appropriate to grade level)

We, as students, will share the responsibility to improve our academic achievement and achieve the state's high standards. Specifically, we will:

- Do my homework every day and ask for help when I need to.
- Ensure all homework is turned in on time
- Complete all class assignments in a timely manner
- Follow the school's behavioral expectations
- Read at least 30 minutes every day outside of school time.
- Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.]

Kids Care Elementary will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
